## PUBLIC NOTICE

Section 77 of the Water Act 2016 requires Water Service Providers to transfer ownership to the County Governments within their areas of operation. Murang'a Water and Sanitation Company Limited (MUWASCO) has successfully complied with the above provision of the law. Further to the above and following the expiry of the tenure of the current Board of Directors of the company, Murang'a County Government hereby wishes to invite applications to fill seven positions in the Board of Directors for the company in accordance with the Water Act 2016, the Companies Act 2015, the Corporate Governance guidelines issued by the Water Services Regulatory Board (WASREB) and all other applicable laws. Successful applicants shall be tasked with professionally steering the company to excellence while applying constitutional values and principles including participatory decision making, inclusivity, integrity, transparency and accountability.

Members of the said Board shall be drawn from various community stakeholder groups within MUWASCO areas of operations as per the Water Act 2016 as follows:-

- One (1) woman from Maendeleo ya Wanawake
- Two (2) women from any other women organizations
- One (1) local professional from the professional bodies nominated from the body
- Two (2) members from the business community and manufacturing community nominated by their bodies
- One (1) person from a duly registered organization of physically challenged persons.

### Eligibility criteria

The applicants must meet the following criteria:

1. Provide a nomination letter from their respective group offices
2. Literate and numerate to at least O-level.
3. Demonstrate experience and acumen in business or any profession of at least 7 years.
4. Demonstrate participation in local development initiatives.
5. A degree from a recognized university will be an added advantage
6. Suppliers or other trading associates of the company are not eligible for directorship in the company.
7. Persons in current professional or social relationships with directors of the company cannot become directors in the company.
8. Must meet the requirements of Chapter Six of the Constitution
